Dear Congresswoman Maloney:

We, the undersigned organizations, would like to thank you for introducing The Breastfeeding Promotion Act of 2009 in the House. By leading the charge in Congress to protect, promote, and support breastfeeding, you have demonstrated a clear commitment to our nation's mothers and children.

Human milk is the optimal source of nutrition for infants, and the United States Breastfeeding Committee joins the U.S. Department of Health and Human Services in recommending that infants be exclusively breastfed for six months, and continue to breastfeed for the first year of life and as long afterwards as mutually desired by mother and infant.

As you know, the evidence for the value of breastfeeding to children's *and* women's health is scientific, solid, and continually being reaffirmed by new research. Compared with formula-fed children, those who are breastfed have a reduced risk of ear, skin, stomach, and respiratory infections; diarrhea; sudden infant death syndrome; and necrotizing enterocolitis. In the longer term, breastfed children have a reduced risk of obesity, type 1 and 2 diabetes, asthma, and childhood leukemia. Women who breastfed their children have a reduced long-term risk of diabetes and breast and ovarian cancers. And studies are looking at the effects of breastfeeding on still other diseases and conditions in which breastfeeding may reduce the risk to mothers and infants.

Breastfeeding also provides a range of economic and environmental benefits for society. The future prosperity of our country greatly depends on the productivity of women, as workers *and* as mothers. Women's economic security and the health—emotional and physical—of mothers and families translate directly into the potential of our future workforce and the vigor of our economy.

Again, we applaud your leadership in introducing The Breastfeeding Promotion Act and stand ready to help you achieve its passage.
