Pasteurized Donor Human Milk Constellation Letter in Support of the Access to Donor Milk Act

We the undersigned, in solidarity with the U.S. Breastfeeding Committee (USBC)-affiliated Pasteurized Donor Human Milk Constellation, are in full support of the Access to Donor Milk Act (ADMA) of 2023 (S. 2819/H.R. 5486) and request your support in passing this legislation. The ADMA is a critical component of the [USBC vision for a robust infrastructure for infant nutrition security](#) in the United States, which includes four pillars: parents, programs, policies, and a plan for emergencies. The vision for the four pillars was codified by the USBC in response to the 2022 infant formula recall and subsequent shortage, but the country's need for an infrastructure to protect and nourish all of our country's youngest people is ongoing.

The American Academy of Pediatrics (AAP) recommends exclusive breastfeeding/human milk feeding for the first six months after birth and continued breastfeeding with addition of complementary foods to two years of age.¹ Donor human milk plays a vital role to support exclusive human milk diets when mother's own milk is unavailable or insufficient. Pasteurized donor human milk is human milk that has been donated to a milk bank. It is specifically processed so that it can be given to any baby, although it is generally prioritized for distribution to the most medically vulnerable infants, including those with very low birth weight or with serious gastrointestinal issues. Pasteurized donor human milk can also serve as a bridge to breastfeeding when there is a delay in mother's milk increasing or a medical need for supplementation. When mother's own milk is unavailable or insufficient, donor milk offers similar benefits, such as optimal nutrition, easy digestibility, and immune protection. The World Health

Organization and the AAP recommend the use of donor milk for low-birthweight infants, as well as for sick infants who cannot be fed their mother's own milk.^{2,3}

Access to donor milk has been shown to reduce infant mortality rates, lower healthcare costs, and shorten hospital stays. Specifically, the use of donor milk is associated with increased survival rates and lowered rates of infections, sepsis, serious lung disease, and gastrointestinal complications.^{4,5} In 2021, there were 383,979 preterm births in the United States, representing 10.5% of live births,⁶ so the potential for health and cost savings is substantial. Data from one study shows that the cost of a neonatal intensive care unit stay for infants at very low birth weight is nearly \$220,000 for 56 days.⁷ The use of donor human milk can reduce hospital length of stay by 18-50 days by preventing the development of necrotizing enterocolitis in preterm infants.⁸ And the benefits of human milk extend beyond the inpatient stay, with infants receiving all human milk diets in the NICU experiencing fewer hospital readmissions and better overall long-term outcomes.^{9,10}

Although donor milk has important health implications for vulnerable infants in all communities and can result in significant economic benefit, donor milk is not accessible equitably across communities.¹¹ **The ADMA would help increase life-saving access to donor milk for more families by:**

- 1) Allowing state agencies to use Special Supplemental Nutrition Program for Women, Infants and Children (WIC) funding to promote the need for and benefits of donor milk and allowing WIC funds to support donor milk activities in states, tribes, and territories;
- 2) Providing emergency capacity-building funding (\$3 million) for milk banks in the event that there is a rapid increase in demand for donor milk, as occurred during the 2022 formula shortage;

- 3) Creating a donor milk awareness program at the Department of Health and Human Services (\$1 million) to educate the public on donor milk, nonprofit milk banks, and to publicize the need for donor milk; and
- 4) Requiring that the Secretary of Health and Human Services draft guidance that addresses appropriate standards for collection, processing, handling, transfer, and storage of donor milk and requiring the Secretary to convene a public meeting to inform this guidance.

Throughout the infant formula recalls and resulting shortages in 2022, milk banks across the country saw a significant increase in inquiries to donate and receive milk. The formula shortages and recalls disproportionately impacted families who were unable to pivot to different formula brands. Milk banks increased their processing rates in response to the increased demand, but more milk banks, depots (drop-off sites), and especially more donors are needed. **The need to invest in an infrastructure that ensures American babies are safely fed has never been clearer.**

The small but impactful investments in the Access to Donor Milk Act provide an extraordinary opportunity for the 118th Congress to save lives while reducing healthcare costs. We, the signatories, reiterate our full support for federal legislation that expands access to and ensures the continued safety of donor human milk. We call on Congress to quickly pass the Access to Donor Milk Act of 2023 to ensure that medically vulnerable infants across the country have access to life-saving donor milk.
